In executing this Contract, I represent and warrant that I am the legal guardian of the Student, and that all legal guardians of the Student have signed this Contract. I also understand and agree that I am jointly and severally liable for all amounts due under this Contract.

I represent and warrant that I have read this Contract and accept all of its terms and conditions, which cannot be changed except by the express written consent of all the parties. This Contract shall be governed by the laws of the State of New York, without giving effect to principles of conflicts of law.
